Our walk is about awareness and unity. Ask your family members, friends, and coworkers to come out and support our children. Let's make this the best walk ever!!!





- Participants will attend a 3 hour training covering inclusionary practices regarding the necessary supplemental aids and services. Training will include behavior, social, sensory, and environmental supports.
- Participants will complete a pre-survey and post-survey that measures beliefs, attitudes and assumptions regarding including students with autism.

#### Participant Letter

#### Beliefs, Attitudes, and Assumptions of Professionals and Parents Regarding Students with Autism and Inclusion

You are invited to be in a research study of professionals and parents beliefs, attitudes and assumptions regarding students with autism in an inclusive educational environment. You were selected as a possible participant because you are either a parent of a child with autism and/or professional for a school district or an agency that supports students with autism in an inclusive educational environment. I ask that you read this form and ask any questions you may have before agreeing to be in the study.

This study is being conducted by myself; Gloria Gigliotti a graduate student for Marywood University who is completing a thesis for a Master's in Special Education

#### Background information:

The purpose of this study is to survey professionals (both in the mental health field and education field) attitudes, beliefs, and assumptions about supporting students with autism in an inclusive educational environment with the necessary supplemental aids and services that will support their competencies, success, and growth. The relationship of these attitudes, beliefs, and assumptions to the number of professional development opportunities with regard to autism will also be investigated. Parents' attitudes, beliefs, and assumptions about an inclusive environment will be compared to those of professionals in educational systems and human services agencies.

The research will answer what are the attitudes, beliefs, and assumptions of professionals and parents supporting student's with autism within an inclusive educational environment.

The research will also inquire does the amount in hours of professional development specific to autism influence or change the attitudes, beliefs, and assumptions of professionals and parents regarding inclusive educational environments with the necessary supplemental aids and services.

#### Procedures:

If you agree to be in this study, I would ask you to do the following things. I would like you to participate in a 3 hour professional development opportunity. The topic to be taught is autism and the necessary sensory, social, and behavioral supplemental aids and service strategies that will support these students in an inclusive educational environment. There will be a pre-survey given at the beginning of the training and a post-survey given at the end of the training. Risk and Benefits of Being in the Study:

The risks are no greater than ordinarily encountered in daily life. However, some items in the survey may cause discomfort in some individuals. Individuals that experience discomfort may contact: Marywood University, Psychological Services Center, at 570-348-6269.

The possible benefit is that professionals and parents' beliefs, attitudes, and assumptions may change, which may contribute to more appropriate inclusionary practices with the necessary supplemental aides and services needed to support students with autism within an inclusionary educational environment.

#### Anonymity

All names, numbers, and email addresses obtain from parent participants will be destroyed the day after the training. The sign-in sheet for mental health professionals will also be destroyed immediately after the training. Once the winning raffle ticket number is drawn, all tickets will be destroyed immediately following the training.

#### Confidentiality:

The records of this study will be kept private. Any sort of report I might publish, I will not include any information that will make it possible to identify a participant. Research records will be kept in a locked file: only the researcher will have access to the records.

Researcher will keep the records stored within the researcher's home in a locked box that the researcher will be the only one who has a key. The researcher after 3 years will destroy the research records by shredding them with a paper shredder and disposing the shredded records appropriately.

#### Voluntary Nature of the Study:

Your decision whether or not to participate will not affect our current or future relations with the researcher, or Marywood University. Your participation is voluntary and withdrawal would only be possible immediately before the presurvey and the beginning of the professional development.
